Dear Members:

We are writing to you regarding bill C-22, the *Canada Disability Benefit Act*. It is currently before HUMA for clause-by-clause consideration. We thank you for your work on this important bill. HUMA has strengthened bill C-22 by voting in favour of amendments to define disability, ensure the Canada Disability Benefit (CDB) is indexed to inflation and direct that the application process is accessible for all people with disabilities in Canada.

We write to express our collective concern with three amendments proposed at the HUMA meeting on Wednesday, December 7, 2022.

- 1. **CPC-1** admirably intends to prevent provincial/territorial clawbacks; however, we believe strongly that the CDB's interaction with provincial/territorial programs and benefits should be a negotiated by the Minister with support of the disability community.
- 2. NDP-5 and BQ-1 seek to embed parliamentary review and/or approval of proposed regulations. This type of review is unprecedented. We strongly believe that the regulations process will be challenging on its own and adding another layer of complexity to the process will delay the CDB's implementation. We are confident that the Minister is committed to the development of regulations with the disability community using a co-creation process.

As a group of organizations of and for people with disabilities who will benefit from the timely passage of bill C-22, we do not support these amendments and ask that they be withdrawn.
