Benefits and tax credits

Don't miss out on the tax credits and benefits you may be eligible for!

File your income tax and benefit return every year Eligibility for certain benefit payments is based on information from your yearly tax return

Community Volunteer Income Tax Program (CVITP)

- Collaboration between community organizations and the Canada Revenue Agency
- Community organizations host tax preparation clinics and arrange for their volunteers to prepare income tax and benefit returns for eligible individuals

"Program in a box"

CRA support to community organizations and their volunteers

- Network of CRA coordinators
- Training
- Free tax preparation software
- Promotional products (also available in 3rd languages)
- Surplus computers, if available
- Advertise your tax clinic on the CRA website
- Toll-free dedicated line to support volunteers throughout the filing season



Who is eligible?

Individuals with a simple tax situation and meet the suggested family income level

Maximum income levels	
Marital status	Family income
Individual	\$30,000
Couple	\$40,000
Individual with a dependant	\$35,000

Interest income less than \$1,000

Quebec residents, verify your income eligibility with an organization that offers volunteer tax preparation clinics in your area

Returns not eligible

- Volunteers do **not** prepare returns for individuals who:
 - have self-employment income
 - have business or rental income and expenses
 - have capital gains or losses
 - have employment expenses
 - file for bankruptcy
 - are deceased in the year
