

ONLINE FINANCIAL LITERACY FACILITATOR TRAINING

Our 7-week online curriculum is designed to prepare frontline workers to deliver an easy-to-use program to meet the needs of Canadians living on low incomes and other vulnerable groups. Participants learn how to adapt the program to the needs, interests and learning styles of the groups they serve.

The online course allows frontline workers to access facilitator training from anywhere in Canada. It has many other benefits as well, including:

- Convenience – you can work on the course on your own time and at your own pace
- Cost effective – no travel costs, less time away from the office
- Easy and fun – interactive course using a variety of learning styles
- Connect with others across Canada – share ideas and best practices with other frontline community workers via a general discussion forum.

The course curriculum covers the following topics:

1. Exploring Your Relationship with Money
2. Income & Taxes
3. Budgeting
4. Banking and Financial Services
5. Saving
6. Credit Basics
7. Credit Reporting
8. Debt
9. Consumerism

At the end of the 7-weeks of training, each facilitator is provided with the following:

- PDF copy of our Financial Literacy Facilitation Toolkit (curriculum) and Facilitation Guide
- Certificate of Achievement
- Link to the PowerPoint presentation
- Evaluation toolkit (online)
- Participant handouts in 13 different languages (online)
- On-going support from Prosper Canada's training staff and network of trained facilitators through information sharing via Prosper Canada's website, newsletter, and Facebook and Twitter accounts.

Fee Structure

Our online course costs \$250, with the option to order a hard copy of the curriculum for an additional \$50 (including delivery costs). Organizations that find this cost prohibitive, may want to seek sponsorship from their community (e.g. financial institution or local business).
